2019 La Grange Little League Sponsorship Form

La Grange Little League (LGLL) and the 700 boys and girls that participate each year are eagerly looking forward to the 2018 season. We are one of the largest and oldest Little League organizations in the area and continuing to grow. Last year was our 62nd year serving the boys and girls in our community. Year after year, operation of the league is a direct result of the participation of our sponsors.

Please consider becoming a sponsor of LGLL this year. By virtue of your contribution, you are not just investing in today's youth but you are helping to shape tomorrow's responsible adults. Additionally, your business receives excellent exposure to families from La Grange, La Grange Park, Countryside and other surrounding communities.

This year we are offering three levels of sponsorship. The "**Home Run**" sponsorship at a cost of \$400 for a 1 year commitment or \$750 for 2 years. The "**Grand Slam**" sponsorship at a cost of \$600 for a 1 year commitment or \$1,100 for 2 years. The Grand Slam sponsorship will include a 3' by 5' banner (can include website and/or phone number in addition to the logo) that will be prominently displayed throughout the season on the outfield fence of A or B Fields at Sedgwick Park.
- **Triple Crown:** Offers all of the same benefits as the Grand Slam level - as well as a larger banner 4' x 6' on one of six spots on the batting cages at B Field.

Dear Mr. O'Brien:

This letter recognizes the La Grange National Little League of La Grange, Illinois, as a chartered member of Little League Baseball, Incorporated, who will be covered under our Federal Group Tax Exemption Number 3158 as described in Section 501(c)(3) of the Internal Revenue Service Code upon completion of the reinstatement process currently taking place with the IRS.

Enclosed is a copy of the IRS Letter of Determination that should be presented along with this letter to any donor that requests proof of your federal tax-exempt status. This tax exempt status applies only to chartered Little League programs.

As a reminder, as part of the requirements set forth by the IRS, all leagues listed under our group number must submit yearly financial statements to Little League International, utilize the same fiscal year as Little League Baseball, Incorporated, which is 10/1 – 9/30 and file the appropriate 990 Form with the IRS annually to retain their tax exempt status. Failure to timely file the required IRS form annually could result in your organization losing its federal tax exempt status. Leagues that have had their federal tax exempt status automatically revoked for failure to file for three consecutive years must contact the IRS for retroactive reinstatement instructions and guidelines.

Dear Taxpayer:

This is in response to your request dated June 20, 2017, for information about your tax-exempt status.

Our records indicate we issued a determination letter to you in May 1981, and you're currently exempt under Internal Revenue Code (IRC) Section 501(c)(3).

We also recognized the subordinates on the list you submitted as exempt from federal income tax under IRC Section 501(c)(3).

For federal income tax purposes, donors can deduct contributions they make to you as provided in IRC Section 170. You're also qualified to receive tax deductible bequests, legacies, devises, transfers, or gifts under IRC Sections 2055, 2106 and 2522.

Because IRC Section 170(c) describes your subordinate organizations, donors can deduct contributions they make to them.

Please refer to www.irs.gov/charities for information about filing requirements. Specifically, IRC Section 6033(j) provides that, if you don't file a required return or notice for three consecutive years, your exempt status will be automatically revoked on the filing due date of the third required return or notice.

In addition, each subordinate organization is subject to automatic revocation if it doesn't file a required return or notice for three consecutive years. Subordinate organizations can file required returns or notices individually or as part of a group return.
