## PARTICIPANT WAIVER

**1. Waiver and Release:** I am fully aware of and appreciate the risks, including the risk of catastrophic injury, paralysis and even death, as well as other damages and losses, associated with participation in a lacrosse event. I agree on behalf of myself, my heirs, next of kin, and personal representatives, to release, waive, discharge, and covenant not to sue Stratford Girls Lacrosse Club, Texas High School Lacrosse League, United States Lacrosse the host organization, and sponsors of any Stratford Girls Lacrosse Club recognized or sanctioned event, along with other participants, sponsors, advertisers, and, if applicable, owners and lessors of the premises used to conduct the event, coaches, officials, referees, umpires, volunteers, employees, agents, officers and directors of these organizations, all of which are hereinafter referred to as "Releasees", from any and all liability to each of the undersigned, and that Releasees shall not be liable for any injury, loss of life or other loss or damage to person or property as a result of my participation, even if caused or alleged to be caused in whole or in part by the negligence of Releasees .

**2. Medical Attention:** I hereby give my consent to Stratford Girls Lacrosse Club and the host organization of any Stratford Girls Lacrosse Club recognized or sanctioned event to provide, through a medical staff of its choice, customary medical/athletic training attention, transportation and emergency medical services as determined to be warranted by coaches, organizers or trainers of Stratford Girls Lacrosse Club at the time it is administered in the course of my participation in Stratford Girls Lacrosse Club recognized or sanctioned events.

**3. Readiness to Participate:** I will only participate in those Stratford Girls Lacrosse Club competitions, events or activities in which I believe I am physically and psychologically prepared to participate.

**4. Publicity Release:** I understand that Stratford Girls Lacrosse Club retains the right to use photographs of Stratford Girls Lacrosse Club members for publicity and advertising purposes in print or online.

**5. Policy Acknowledgment:** I have read, understand and agree to be bound by the expectations and requirements set forth in the Stratford Girls Lacrosse Club Policy Manual. I also recognize that failure to follow such policy may, depending on the violation, result in my dismissal from the Stratford Girls Lacrosse Club for a period or permanently.
