I understand that this information will be used, in part, to determine my suitability for a volunteer position with AGSL and that as long as I remain a volunteer with AGSL, the criminal history records check and motor vehicle driving records check may be repeated any time. Upon my request, I will have an opportunity to review criminal history and motor vehicle driving records obtained by AGSL.

I WAIVE, RELEASE AND DISCHARGE AGSL, its officers, directors, employees, volunteers, agents and representatives from any liability for all damages and losses of whatever kind or nature that may result in connection with AGSL conducting a criminal history records check or motor vehicle driving records check on me. I understand that I will be using facilities at my own risk and I, on my own behalf, hereby release, discharge, indemnify and hold harmless AGSL from all liability for injury or accident to person or damage to my property. I understand that my volunteer service can be modified or terminated with or without notice or cause, at any time, at the option of AGSL or at my option and that AGSL may, in its sole discretion, decline to accept my application for volunteering with or without cause. In the course of volunteering for AGSL I may be dealing with confidential information regarding athletes and volunteers involved in the program and I agree to keep said information in the strictest confidence.

I understand that by accepting my role as either Manager or Coach of the above mentioned team that I am responsible for how I conduct myself on and off the softball field. I further understand that the children on my team, as well as their parents, take their lead from me. As such I promise to teach proper sportsmanship by example. In doing so I make the following promises:

1. I will keep all confidential information given to me as a Manager/Coach confidential.
2. I will have a parent meeting with my team, prior to our 1st game, in which I will highlight the importance of sportsmanship both on and off the field. I will make it clear that sportsmanship towards umpires, team-mates and the opposing team is expected from players, parents, and coaches alike. **Unsportsmanlike conduct will be reported to the Board if not corrected.**
3. I understand that I am responsible for the conduct of my player's parents, as well as my players. I will ensure adherence to an umpires request to have a player, parent, or fellow coaches quieted or removed as needed.
4. I will follow the rules of the game, which include the local rules as outlined by AGSL and those affiliated with the tournament games we participate in.
5. I will NOT work out nor accept any "Gentlemen Agreements" that are designed to alter and/or ignore the rules of the game as outlined by AGSL.
6. I will not argue with, or make derogatory comments to, the umpires, opposing Coaches or players nor will I allow my players and/or their parents to do so. I will teach, by example, my players and their parents to respect the officials on and off the field.
7. I understand that I can and will be held responsible if any of these rules are broken. I further understand that penalties issued to me may include suspension and/or termination of my Manager/Coaching responsibilities. If I am released from my Manager/Coaching responsibilities in any given season that can and most likely will affect any opportunity I may have in future season t to Manager/Coach
