

MEMORANDUM OF UNDERSTANDING

BETWEEN

Ashburn Youth Football League (AYFL), Central Loudoun Youth Football League (CLYFL), Lower Loudoun Boys Football League (LLBFL), and Upper Loudoun Youth Football League (ULYFL).

This MEMORANDUM OF UNDERSTANDING is hereby made and entered into by and between the Ashburn Youth Football League, hereinafter referred to as AYFL, Central Loudoun Youth Football League, hereinafter referred to as CLYFL, Lower Loudoun Boys Football League, hereinafter referred to as LLBFL, and Upper Loudoun Youth Football League, hereinafter referred to as ULYFL.

A. PURPOSE

The purpose of this MOU is to formally codify the creation of Loudoun Youth Football Association (LYFA). By forming this partnership all leagues agree to operate by the same rules, safety procedures and operating processes. In turn this will allow in-season interleague play as well as an integrated championships at each division. Each league will participate as individual operating entities within the association, retain operational independence, and continue to award separate league champions.

B. STATEMENT OF MUTUAL BENEFITS AND INTERESTS





Each league agrees to this partnership to ensure the continued participating and development of youth football serving Loudoun County and surrounding areas. The benefits include increased awareness, marketing, and excitement.

C. MEMBERS SHALL

1. Operate by the same rules for tackle football as developed by the joint committee composed of members from each league, published on the LYFA Dropbox site ("INSERT LEAGUE - ABC Division Tackle Football Rules – 2016", dated 16-FEB-2016).
2. Operate by the same operations manuals as developed by the joint committee composed of members from each league, published on the LYFA Dropbox site ("INSERT LEAGUE - Operations Manual - 2016", dated 25-FEB-2016).
3. Present any modifications or changes to the above documents to the other participating members for discussion and agreement on how to resolve. Any agreed-upon modifications will be documented as addendums to each document.
4. Any topics that cannot be resolved will be presented for resolution to a committee (i.e., the "LYFA Executive Committee") that will be composed of members from each represented league. The LYFA Executive Committee will be comprised of the President for each participating league as well as one additional, active Board of Directors member from that league. This committee will be chaired by each of the participating league on a basis to-be-determined and documented by this committee. The committee will meet on a quarterly basis to discuss this MOU and any issues identified by any/all participating members.

5. All members will be partnered with USA Football.
6. Refer to the defined entity as "Loudoun Youth Football Association" or "LYFA" in all marketing efforts, promotional materials, and league communications.
7. Use the agreed upon logo to represent LYFA, published on the LYFA Dropbox site ("LYFA7.jpeg", dated 21-FEB-2016; "LYFA7sm.jpeg", dated 21-FEB-2016).

This agreement is dated 29-February, 2016 to be reviewed and renewed (optionally) on an annual basis. By signing below all parties agree to operate in good faith as specified herein.
