

4. MEMBERSHIP TERMS & CONDITIONS

Acknowledgment of Risks, Injury & Obligations

I acknowledge that the activity I am to undertake is a dangerous activity and that by participating in it I am exposed to certain risks.

I acknowledge and understand that while participating in such activity;

- I may be injured, physically or mentally.
- My personal property may be lost or damaged;
- Other persons participating in such activity may cause me injury or may damage my property
- I may cause injury to other persons or damage their property
- The conditions in which the activity is conducted may vary without warning
- I may be injured or die or suffer damage to my property as a result of the negligence or breach of contract of Amenzone.
- There may be no or inadequate facilities for treatment or transport of me if I am injured
- I assume the risk of and responsibility for any injury, death or property damage resulting from my participation in the activity.

Release and Indemnity

I participate in the activity at my sole risk and responsibility. I release, indemnify and hold harmless Amenzone, its servants and agents, from and against all and any actions or claims which may be made by me or on my behalf or by other parties for or in respect of or arising out of any injury, loss, damage or death caused to me or my property whether by negligence, breach of contract or in any way whatsoever.

Administration

Appropriate covered footwear & a shirt must be worn and towels must be used at all times while in the gymnasium. Memberships are not refundable or transferable. All equipment must be put back after use. Photo ID cards (i.e. student card or drivers license) must be carried and shown upon request. Each member must respect other gym users and behave in an appropriate manner at all times. Amenzone Staff reserve the right to rescind the rights of members not complying with the terms and conditions of the membership. No one under the age of sixteen years (16) will be permitted to enter the gymnasium without consent from their legal guardian.

Membership Cancellation Policy

To cancel a membership, members must meet with an Amenzone staff member. The member must also provide written notice of cancellation and lodge it to Amenzone Staff 10 days in advance. Cancellations received after this date cannot be processed until the following month.

Membership Hold

A member may hold their membership for a maximum of 1 month. If a membership hold exceeds 1 month, the members will be required to pay the \$95.00 signup fee. A member must specify a start and finish date of the hold. Early reactivation is permissible. To suspend a membership, the member must complete a suspension form and lodge it to Amenzone prior to the commencement of their suspension.

Personal Training Cancellation Policy

Our goal is to provide quality personal training sessions in a timely manner. This policy enables us to better utilize available training sessions for our clients. Your training session time is reserved just for you, so please arrive on time, as your session will end as scheduled. Furthermore, we ask that you show consideration by notifying us by 6:00pm the day before your personal training session, if you are unable to attend. Failure to give the notice necessary prior to cancellation will result in the charge of one full session of personal training.
