8. Coin flip



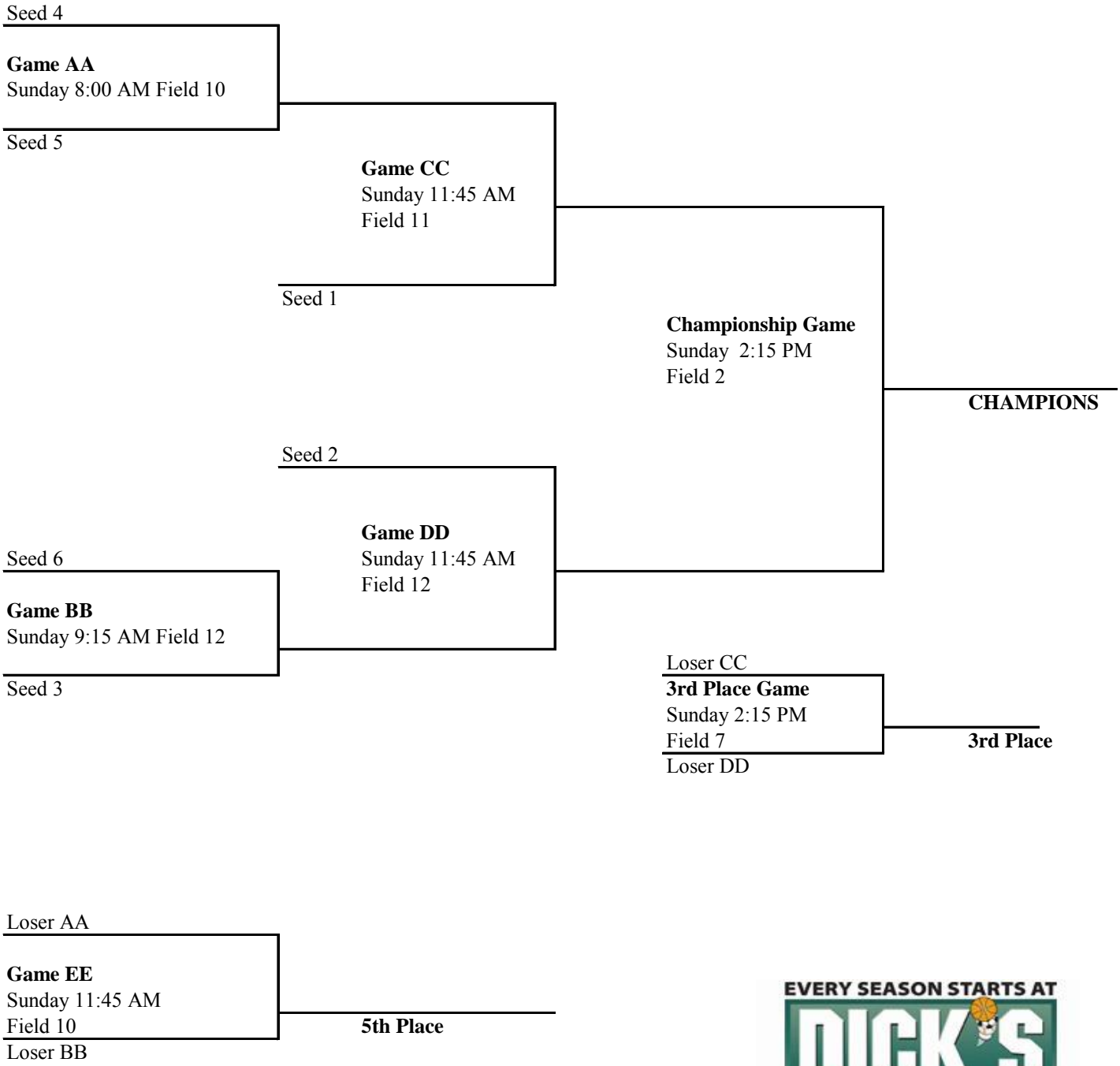

If the tied teams did not all play each other in pool play, criteria #2 will be the first condition considered. If criteria #2 does not break the tie, criteria will be considered according to the list above.**

****If at any point during the breaking of a 3 (or more) way tie, one team is determined to be either the highest or lowest available seed and the remaining teams are still tied, the process will revert back to head to head and then down the list.**
