**NOTES:**

- Umpires are to be paid at the pregame meeting at the plate. All payments will be in cash and team shall have exact amount due.

-There is no assignment or scheduling fees due by any CBA team. These fees are covered by the CBA as part of your registration fee.

-On games that need to be rescheduled, the new location, date, time(s) should be confirmed by both managers. Games that need to be rescheduled should be given 7-10 in advance. From there, the "hosting" manager should contact the appropriate lead umpire in chief to confirm their participation. From there, the league division manager should be contacted with all information in order to update the CBA website.

-On games called by weather, the umpires shall receive full pay for the game if it has begun. If the game is called less than 2 hours prior to the start time, each umpire will receive \$ 30 show up fee. If the game is called more than 2 hours prior to the start time, no fees/payments to umpires are required by the teams.

-All decisions made by the umpires are final. Disputes should be handled in private, in a respectable manner, outside of earshot of others.
