WYSC's code of conduct is intended to assist with all aspects of WYSC's Basketball program and to provide coaches, parents, players and guardians clear guidelines to ensure the club runs smoothly on a day to day basis. The emphasis of the code of conduct is to provide all club members a clean understanding of club policies.

WYSC's basketball program is a competitive league. Players are NOT guaranteed equal playing time. It is the coach's job, responsibility, and discretion to manage playing time. This is our number one rule.

The safety of players is the highest priority. **Please take a minute to carefully read the Code of Conduct before signing the agreement.** By registering with the club, the parents/guardians and the players agree to the following code of conduct.

PLAYERS BEHAVIOUR:

1. Players will act in a positive manner at all times, both during practices and games.
2. Players are expected to demonstrate Fair Play and good sportsmanship at all times.
3. Abusive language or bullying of any kind will not be tolerated.
4. Players will show the outmost respect for referees at all times. Talking back to a referee is not permitted.
5. Players will show the outmost respect to opponents.

PARENTS/SUPPORTERS BEHAVIOUR:

1. During the games parents are NOT to coach from the sidelines. Coaching is the responsibility of the head coach.
2. Parents and spectators are asked to support the team and players WITHOUT pressure, to praise effort as well as performance, and to encourage and praise regardless of game's outcome.
3. Restrain from making any type of comments to the referees.
4. All parents and spectators will act in a professional manner at all times.
5. Parents and spectators are expected to demonstrate Fair Play and good sportsmanship at all times.
6. Communicate with the coaching staff any player / parents concerns with the coaching staff.
